A work session with the Board of County Commissioners is scheduled for **Wednesday, January 22, 2013, at 10:30 a.m.** to discuss the results of the rural preference census. The work session will be held at the Public Service Center, 1300 Franklin Street, Vancouver, and is open to the public.

The county surveyed owners of properties zoned for agriculture (AG-20) and forest (FR-40) to determine preferences of these owners for a smaller minimum parcel size. In November 2013, owners of AG-20 parcels larger than 10 acres and FR-40 parcels larger than 20 acres received letters asking for their preferences. The Board of County Commissioners will use the results to decide if changes are needed in the county's rural lands policy. Any changes would be done as part of the 2016 Comprehensive Plan Update.
