The Open Houses on the Supplemental Environmental Impact Statement (SEIS) in Vancouver, Camas, Ridgefield, and Battle Ground were held last month and the comment period for the SEIS portion of the process was closed on September 1

Staff is working on compiling the comments from the SEIS Open Houses and creating a summary statement report, which will be posted on the website as soon as it has been completed

There will be a follow up worksession with the Planning Commission on Thursday, September 18 and the Board of Commissioners on Wednesday, September 24 to review the summary report prior to starting the work on the SEIS document
