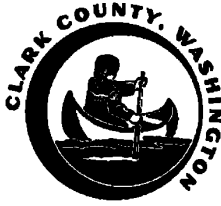
for their consideration. Should you further concerns, let's discuss your thoughts at our next meeting in Woodland on July 10, 2015.
