I believe that keeping it in the hands of our young family members who know and love the land is the best chance to continue the hands-on, sustainable, long-rotation growing of timber that this land is so well suited to.

With respect, I believe that the current Alternative 4 map of forestry parcels is the most realistic and sensible treatment that the Growth Management Planning Process has produced.
