Hi Eileen,

Thanks for contacting us about the challenge you are facing with the review of your comp. plan. It is really a huge document to review in a short amount of time. Unfortunately, however, RCW 36.70A.130 established the deadlines and the Legislature did not give us the authority to extend them. You probably know that if the County misses its adoption deadline of June 30, 2016 established under [RCW 36.70A.130 (5)(b)], it will not be eligible to receive some grants and loans from the state until you adopt your plans and regulations and come into compliance with the GMA.

If you know that you cannot meet the deadline, you could send us a progress report outlining how much work you have completed and your projected adoption date. While this will not provide us with the authority to extend your deadline, it will help us document your progress.

I am a member of the Clark County Planning Commission and we are currently reviewing the Comprehensive Plan and will have several meeting in the next few weeks.

I understand that a draft has been sent to your office at the Department of Commerce for review.

Is there a procedure which the County Councilors could use in order to request additional time to deliberate on the Comprehensive Plan? There has been a major change to the plan since February of 2016, and the materials that have been handed off to the Planning Commission are voluminous. I believe that because the sheer volume of information and the changes that only recently took place, it requires a more deliberate

process in order for questions by the volunteer Commissioners to be answered and for more input from the people of Clark County

If there is a process, I assume it would be either in the statues or the administrative rules. If so, I would greatly appreciate your direction in finding that information.
