This notice announces the County's intent to adopt the 2007 Comprehensive Plan update EIS pursuant to WAC 197-11-600 The 2007 Plan FEIS covered all of unincorporated Clark County within a "maximum study area" (MSA) The 2007 Comprehensive Plan urban growth areas (UGAs) were established within the MSA Court challenges to de-designated agricultural land resulted in further shrinking of UGAs The current UGAs are not proposed to change Because of the relative lack of growth in the county since the 2007 Plan was adopted, the county will rely on the FEIS done for the 2007 Plan and supplement it with environmental analysis, as needed, pursuant to WAC 197-11-620
