
Proposed Alternative 4:

- Recognize existing parcelization for parcels <9.5 acres
- AG -20 to Rural
 - 682 parcels / 2864 acres
 - 554 developed, 128 undeveloped
 - 68 in current use, 10%
- FR-40 to Rural
 - 844 parcels / 3673 acres
 - 680 developed, 164 undeveloped
 - 68 in current use, 8%

Proposed Alternative 4:

- Technical adjustment to resource designations
 - 1993 Farm Focus Group/ Forest Group designation criteria
 - No technical adjustments in 20 years
- The parcels have already been divided
 - Primarily vacant in 1994, mostly developed in 2015
 - AVG parcel size is 4.2 for AG and 4.4 for FR
- Current use rate reflects rural use not resource use
 - Rural parcels <9.5 acres 8.7%
 - Resource parcels >9.5 acres excluding public owned 83%



- Alt 2 FR-20 Clustering
- TDR –Resource to Rural
- Recognize adjacent parcel size in Rural area

Issues & Implications

- Legal Issues Raised by Alternative 4
- 1. SEPA analysis will be required.
- 2. De-designation must be justified.
- 3. An unknown number of these properties are not legal lots.
- 4. Some instances of spot zoning appear on the map.
- 5. The proposal must be consistent with rural character.
