NOTICE IS HEREBY GIVEN that the Board of Clark County Councilors will conduct a public hearing on TUESDAY, October 20, 2015, at 10:00 a.m., at the Clark County Public Service Center, 1300 Franklin, Vancouver, WA, to consider the following:
RECOMMENDATION FROM THE CLARK COUNTY PLANNING COMMISSION ON A PREFERRED ALTERNATIVE FOR THE 2016 COMPREHENSIVE PLAN UPDATE
Clark County is updating its comprehensive plan to meet the 2016 Growth Management Act deadline. As part of the update process, the county is required to analyze the impacts of growth alternatives through the SEPA process. The county re-adopted the environmental impact statement (EIS) prepared for the 2007 update and prepared a draft supplemental EIS (DSEIS) to analyze four (4) potential growth options for the 2016-2035 time horizon. The Board and the Planning Commission held a joint public hearing on the DSEIS on September 3 and 10. On September 17, the Planning Commission decided on its preferred alternative to recommend to the Board.
The purpose of the hearing is to take public testimony on the Planning Commission recommendation for a preferred alternative. The Board will select a preferred alternative, and a final SEIS will be prepared on that alternative.
