Mr. McCauley,

The work being done by Councilor Madore appears to violate Provision 2.6(B)(3) "Requesting information or advice pertinent to the legislative deliberations and actions of the council from any officer, agent, employee, contractor or vendor subject to the direction and supervision of the county manager or other elected official."

There is a wide difference between requesting information or advice and directing staff to do certain work and then tell staff to keep their internal drafts out of the public record and/or not produce information that is inconsistent with one councilor's proposals prior to the public hearing on, much less adoption by the council, of those proposals and/or policies. I know of no exception to the PRA which would allow for such hiding of public records from the public view. If you or Mr. Horne have an exception, or reason why these actions with regards to planning staff and GIS staff do not violate the charter provisions and/or are exempted from disclosure from the Public record, then please advise. If I do not receive a response, I will assume they are violations of the charter and are there is no public record exemption for the internal drafts to which Councilor Madore refers to in this e-mail exchange.
