Dear Councilor Madore,

I was stunned to see the accusations made against you by Oliver Orjiako. The allegation of racial discrimination is patently false. I have observed the two of you in meetings with staff and in public. You have never shown him any type of disparate treatment or racially motivated disparate treatment.

In the past I have worked to help the black community and in particular the black business community in Seattle fight against the discriminatory practices of the Seattle Police Department, I have also helped Gay business owners fight against the discrimination they faced with the Washington State Liquor Control Board. I am fully aware of discrimination when I see it and I have never seen you display any type of discrimination toward Mr. Orjiako.

I believe Mr. Orjiako's complaint is malicious and being used as a club to silence your criticism of the staff's work on the comprehensive plan. I am more than willing to testify or submit a declaration regarding how you have treated Mr. Orjiako. I believe that Mr. Orjiako is engaging in libel against you. Mr. Orjiako's claims are baseless and shameless.

County planning director files complaints against Madore

Orjiako levels whistle-blower, harassment complaints (Excerpts below)

Madore's controversial zoning proposal, Alternative 4, and related planning framework introduced by the councilor violate the Growth Management Act and "cannot be supported" by state law, Orjiako said.

Whistle-blower

In the report, Ferguson details Orjiako's complaints about Madore's "solitary efforts" to develop Alternative 4, a zoning proposal that would have allowed for small lot sizes in rural Clark County. The council overturned Alternative 4 earlier this year.

Ferguson alleges that Madore has stepped on the role of the planning department, "alienated staff" and "pre-empted public participation," violations of the Growth Management Act and Clark County's home rule charter

The complaint alleges that Madore has worked to engage with and hire outside consultants "who he hopes will deviate from the (Growth Management Act) "

Ferguson goes on to write that Madore has retaliated against Orjiako for attempting to oppose these efforts. Madore has accused staff of using "covert software" to "grossly inflate" how many lots Alternative 4 could create in order to promote an "anti-rural growth agenda," according to a Feb 22 Facebook post by the Republican councilor.

But Orjiako has done just the opposite, Ferguson wrote, saying the planning director has worked in "good faith" to uphold the rural character of Clark County in accordance with growth management laws.

"Accusations of fraud, deceit and pursuit of an 'anti-rural growth agenda' have been leveled against my client with complete disregard of the mandates of the (Growth Management Act) and absent any objective factual basis," Ferguson wrote in the complaint.

Orjiako also denied that county planning staff are or have ever used illicit software in order to promote an agenda.

"There is no hidden agenda, covert software, whatever," Orjiako said.

In the complaint, Orjiako asks that the Clark County council adopt a resolution affirming it will follow the Growth Management Act, and asks an independent investigation be conducted into Madore, "his abuse of public office, official misconduct and perpetual conflicts of interest."

Hello Margaret,

There's no truth to any of this. Councilor Madore has never discriminated against anyone. If anything, the current council and Oliver are discriminating against him.

Oliver simply doesn't want the truth to be exposed. Alt 4 was composed strictly by the books, almost word for word in the GMA and from the courts. The first draft came right from the GMA, word for word.

We are quite comfortable that it will pass muster in the courts and with the GMA. Oliver complains that Councilor Madore worked on Alt 4, which is unusual but certainly not illegal. Nothing in the GMA dictates who presents the proposals, but it does direct who is responsible for deciding what it will be, and that responsibility falls directly on the councilors.

But, Councilor Madore had no choice, because staff refused to follow the commissioners' directive to do the work for them. What won't pass muster is the current proposed Alternative that is planning for far below what the state requires within the OFM population projection. Oliver knows this.

I think RCW 36.70A.215 tells it all, and I think it would be important to see those yearly reports that are required by the state under the GMA. In addition, it has been clearly confirmed that all of the resource land designated in Clark County was done with photos and staff, not the NRCS manual as is directed by the GMA.

We can easily prove this. Oliver knows this, too. If all of this is exposed, Oliver has a lot of explaining to do. Councilor Madore has discovered how it was all done, and is bringing it out in the open. He wants a Plan that is fair and accurate.

He's looking out for the taxpayers of Clark County, and we should commend him for the intestinal fortitude to do that. It's the right thing to do. All he is asking of Oliver is to explain things and make corrections.

But, Oliver is not inclined to do that and he doesn't want the public to know what has been happening all these years. As he told a staff member, "I don't care if I am in the courts for 20 years, I'm not changing the rural lands."

A landowner overheard him say this and reported it to CCCU. Oliver has forgotten that he is advisory only, and it is not up to him to make those kinds of policy.
