SUBJECT Response to question on approval of Growing Healthier Report and Aging Readiness Plan

---

This is a response to Councilor Madore's question posed to staff at the BOCC Work Session on April 27, 2016 regarding the process of approval for the Growing Healthier Report and Aging Readiness Plan. Below are the hearing dates and links to the video where each of the report/plan was adopted and direction provided to staff. The action by the BOCC for the Growing Healthier Report was specific to incorporate the Growing Healthier Report's goals, objectives and policies into the Comprehensive Plan.

The Aging Readiness Plan was adopted along with the formation of the Commission on Aging to implement the plan. It is in our professional opinion, given the breadth and depth of community support of the Aging Readiness Plan, that the proposed policies for the Comprehensive Plan are in keeping with the BOCC's charge to implement the Aging Readiness Plan. Since the approval of both reports, staff has been discussing with the BOCC at work sessions the plan to incorporate the reports into the Comprehensive Plan update. The proposed policies are still subject to BOCC approval to be added to the Comprehensive Plan.
