The following email exchange between Oliver Orijako and Susan Rasmussen demonstrates that there is conflicting statements by Mr Orijako. The July 15, 2015 audio cannot be accessed on the Grid, by the public on April 23, 2016. The statement Mr Orijako made, "**There is no direction not to incorporate the growing healthier report or the aging readiness plan where appropriate in the comp plan.**" is not true.
