**DEIS for Vancouver Energy**

Mark McCauley, County Manager providing some background and passed around proposed comments he would like to prepare for the Vancouver Energy / Tesoro Savage project. He asked for the Councilor's input by January 19<sup>th</sup> via email. Further discussion ensued. Taylor Hallvik, Prosecuting Attorney's office, Marlia Jenkins, Budget Office, and Mark Wilsdon, Risk Management joined the discussion.

**Councilor Reports**

Madore spoke about Tuesday's hearing and a document he presented called "Actual Revenue Situation Report." He asked for it to be added to the grid. Boldt inquired about the grid's policy McCauley responded Stewart stated her concerns with putting the document on the grid and wants to avoid any confusion of non-official and official county documents. Further discussion ensued about what information should be on the grid and possibly setting up a policy. Madore spoke about the transparency on the grid Madore asked that the prohibition not be applied retroactively to his PowerPoint presentation. Further discussion ensued Olson stated she shares Stewart's concern. Olson stated she would like to discuss the policy further at the Board retreat. Boldt joined the discussion and suggested waiting until after the retreat to see what the Board wants collectively on the grid It was decided by the majority of the Council to not post the document in question to the grid but to have a discussion at a later date to decide what documents should be posted to the grid and who should have the authority to post to the grid

**Work Session Request – Clark County Economic Development / Employment Land Supply**

Jeff Swanson, Director of Economic Development provided some background Madore inquired about John McKibbin's presentation at RTC and the of CRC project Swanson responded Madore stated his concerns with funding with the Columbia River Economic Development Council (CREDC). Swanson explained the request further. Further discussion ensued

**ACTION:** The Board approved scheduling the work session.


Boldt inquired about having setting up a work session regarding the fee waiver program. McCauley responded and confirmed he would set one up.




